For quicker processing of your child's application, please have the following documents ready to upload or provide to your enrollment specialist.

- Your child's certified birth certificate (from court house).
- Copy of IFSP or IEP if applicable.
- Custody documents, if applicable.
- Proof of income for the last 12 months one or more of the following: tax forms (W-2 Form):
 - o Three most recent check stubs OR
 - Unemployment statement; child support received, DHS statement (FIP, SSI, etc.), EBT card, SNAP, or other food assistance documents <u>OR</u>
 - o Day Care Assistance Form
- Proof of residency (ex. Drivers license, rent receipt, utility bill, or property tax bill).

*If you are unsure about what documents to bring, please ask your enrollment specialist.
