The staff continue to receive training and support from Alt-Shift along with the curricular leadership team. Daily schedules were created to reflect time to work on goals and objectives. As a result, students are achieving their IEP goals. They are improving their reading, writing and math goals in the 9-12 setting. 20 out of 20 students made progress in their reading and math goals through January. 11 Female students and 9 male students made progress on their reading and math goals. Therefore, 100% of COP students 9th-12th grade made growth on their personalized IEP reading and math goals.
